ATC members met with Athens Services and Department of Public Works (DPW) to identify spots in Altadena with chronic problems so that residents don't have to call each time:


- Sacramento east and west of Marengo

 - Barking dog LA County Code applies to roosters as well



NEED TO MAKE A BARKING DOG COMPLAINT?

We understand excessively barking dogs can have a negative effect on the quality of life in your neighborhood. Unfortunately, there is no immediate solution to complaints of excessive animal noise.

Here are the steps you can take to begin filing a complaint if you live in one of our 11 animal control cities:

Step 1: Report the excessive barking to the Pasadena Humane by calling 626.792.7151 ext. 217. You must provide the full address, including the unit or apartment number (if applicable), of where the dog lives, as well as provide your full name and address so that we may send you a blank petition and logs by USPS mail.

Step 2: Pasadena Humane will make an effort to find resolution to the issue by contacting the dog's owner or guardian and providing them with advice on how to reduce their dog's barking. Most complaints are successfully handled via communication and education.

Step 3: If the issue is not resolved once the dog owner has been contacted, you may begin the formal legal process to have the dog declared a "public nuisance" by completing the forms (the petition and logs) that were provided to you.

Step 4: Once you and your neighbors have completed the forms, they must be submitted to the Pasadena Humane Field Services Department.

Step 5: Once Pasadena Humane has received the completed forms and verified that everyone who signed the petition and completed a log is willing to attend a hearing, the case is forwarded to the City or to the County (depending on jurisdiction) for review and consideration for a hearing.

CURRENT LASD PARKING ENFORCEMENT GUIDELINES

- March 16, 2020, DMV requests LE exercise discretion in enforcement of expired registration and driver's licenses.
- April 22, 2020, Governor Newsom issued Executive Order N-54-20, which prohibited enforcement of certain vehicle code provisions.
- LASD relaxed enforcement of Non-hazardous violations.
- No citations for expired registration, missing license plates and similar equipment violations, street sweeping violations.
- Hazardous citations such as blocking roadway, fire hydrant, red zone/fire lane, handicap, metered parking in business districts, are still issued.
- Abandoned vehicles and 72-hour parking are case-by-case basis.

SAVE OUR STATION

- May 4, 2020, Sheriff Villanueva announces closing of Altadena
 Station and other units due to budget cuts. Altadena will merge with
 Crescenta Valley Station
- June 30, 2020, The Board of Supervisor's approves a budget which includes the possibility of 1,400 positions lost and 300 layoffs.
- Sheriff Villanueva announces new cuts that do not include closing Altadena Station.

But we are not out of the woods yet:

- August 4, 2020, The Board of Supervisors voted to place Measure X on the November ballot seeking to "redistribute" funding away from public safety. (Supervisor Barger was the lone NO vote).
- Altadena Station could still close if it passes.

TYPES

- Investigative Investigations Into Events
- Auditor Evaluate Police Investigations

- Monitor Evaluate Systemic Issues
- Review Board Audit, Review, Monitor, Facilitate Community
 Forum

PROS

- •Hold police accountable for their actions, policies, and organization
- Improves Community Relations
- •Helps Public Understand LE policies and procedures

CONS

- •Costs (\$5.4M for OIG)
- •Not always independent (Political Agenda)
- Requires Political Will
- Qualifications of Members
- Not familiar with "police tactics"

CIVILIAN OVERSIGHT

Steps to Establishing Effective Oversight

- Must have strong core of concerned citizens
- Clearly articulate need and goals
- Establish a planning / advisory committee with officials from all sides
- Identify goals and objectives
- Select oversight structure
- Identify staffing and budget needs
- Present proposal to the public
- Work with community to build support

CURRENT COMMUNITY INVOLVEMENT OPPORUTNIES

Community Advisory Committee

Comprised of a cross section of the community who meet monthly to discuss problems, share ideas, and collaborate on solutions.

Volunteer Program

Members from the community who have demonstrated a willingness to maintain a high quality of life in the area they live in.
