















Water Shortage Emergency_ Impacted SWP Areas




STATE AND METROPOLITAN ACTIONS

- DECLARATIONS AND EXECUTIVE ORDERS BY GOVERNOR NEWSOM ASKING FOR CONSERVATION
 - UP TO 30% VOLUNTARY CONSERVATION
 - NONFUNCTIONAL TURF
- METROPOLITAN'S BOARD DECLARED A WATER SHORTAGE EMERGENCY CONDITION AND APPROVED AN EMERGENCY WATER CONSERVATION PROGRAM FOR STATE WATER PROJECT DEPENDENT AREAS IN APRIL 2022.
 - ONE DAY IRRIGATION OR VOLUMETRIC LIMIT
 - LIMIT SWP DELIVERIES TO SWP DEPENDENT AREAS OF DISTRIBUTION SYSTEM
 - DVL TO MILLS AND CRA THRU GREG AVENUE
 - EXCHANGES WITH OTHER AGENCIES

FOOTHILL AREA ACTIONS

- AUGUST 2021 STAGE II (GREEN) INCREASED WATER CONSERVATION
- NOVEMBER 2021 STAGE III (YELLOW) EXTRAORDINARY WATER CONSERVATION

FOOTHILL MWD CONSERVATION GUIDANCE

- LIMITED WATERING BASED ON RETAIL AGENCY
- FIX LEAKS WITHIN 48 HOURS
- HAND-HELD BUCKET OR HOSE WITH A SELF-CLOSING WATER SHUT-OFF NOZZLE TO WASH VEHICLES
- LIMITS ON FILLING OR REFILLING ORNAMENTAL
 LAKES OR PONDS EXCEPT TO SUSTAIN AQUATIC LIFE



Current Program Information

- Metropolitan offers a base rebate of \$2/square foot (sf) of turf replaced
- Maximum 5,000 sf per project
- Minimum three plants for every 100 sf
- Modifications to convert/remove over-head sprinklers
- Projects must include at least one sustainability element
 - Rain garden or rock garden
 - Dry river bed
 - Rain barrel or cistern
 - Swales or berms or grading

Current Turf Replacement Program



- Base rebate of \$2/square foot (sf) of turf replaced
- Maximum 50,000 sf per project
- Minimum three plants for every 100 sf
- No hardscape except permeable hardscape
- Modifications to convert/remove over-head sprinklers
- Projects must include at least one sustainability element
