

ATC

- The Purposes of the Altadena Town Council are to: (1) act as an ombudsman for the neighborhoods of Altadena, conveying the needs and wishes of the residents to any county state or federal governmental body or agency, and (2) provide a forum for a town meeting in which to discuss issues of concern to the Altadena Community.
- The Altadena community consists of approximately 43,000 residents
- Supervisor Antonovich looks to the ATC for communication of residents' concerns
- Meets the third Tuesday of every month
- Meetings include:
 - Public Safety Reports
 - Community Reports usually of events of interest to the community
 - Votes on Land Use Items
 - General Public Comment

Land Use Committee

- Meets the **first Tuesday** of every month
- Provides a process to gather resident comments on active Conditional Use Permits (CUPs) through door to door canvassing and public comment at committee meetings
- Communicates resident comments to the appropriate planners at Regional Planning
- Votes to recommend action to the ATC
- Is an active "working committee" to review projects and perform due diligence

- How do you interact with Supervisor Antonovich to get "action"?
- What types of items come before the LUC and who presents?
- What is the CSD Committee?

Gloriana Casey:

I would like to ask about how we get parking changed over here on Fair Oaks. We're having a tough time with the residents and/or friends of the apartment building(s) across the street from us parking where our customers could/should be parking. We'd love to see diagonal parking on this nice, wide street, and enforced parking limits. At present, there is a 1-hour limit, but no one ever checks.

I have some questions regarding street cleaning and large item pick-up. It seems the streets of Altadena are dirtier and large items are left on curbsides for months. What is being done to keep Altadena a clean town? Are plans in the works to have Athens and other businesses help with keeping the streets clean?

2. What can people do with just a simple garden hose? I have read that if the fire is bigger than the size of the top of a dining room table, then it is an out-of-control fire.....should people stop and leave, or continue to stay to try to minimize the fire?

Recently, a neighbor removed a beautiful tree that was just a couple feet away from the curb. A private company removed the tree, not Asplundh, the normal contractor for county work.

The removal of the tree takes away from the beauty of the street. Had I and other neighbors known this was going to happen, we would have opposed the work. Some neighbors think the work occurred without permits, but we have no way of knowing.
